PRE - HISTORY



"New Generation" Humanitarian NGO (NGNGO) is a non-commercial social organization established in 1998 to promote the protection of human rights and advocacy of the society, to provide material and non-material assistance to private individuals and legal bodies, and to carry out various effective social initiatives, including support in the implementation of the obligations assumed by the Republic of Armenia under 1975, Helsinki Final Act of Conference on Security and Co-operation in Europe, and 1948, UN Universal Declaration of Human Rights, European Convention for the Protection of Human Rights and Fundamental Freedoms, International Covenant on Civil and Political Rights, International Covenant on Economic, Social and Cultural Rights and the international agreements accepted within their framework, as well as other international legal acts on Human Rights Protection.

The Organization has a clearly defined structure, scope of activities and strategy.

NGNGO has realized numerous projects within its activity. It is one of the most active organizations in Armenia not only because of the variety of the projects, but also as it has the abilities to cover the whole Armenia. It has a qualified full staff and a technically developed equipment. The Organization office is situated in Yerevan.

Memorandum of understanding

The two organizations

- "New Generation" Humanitarian NGO (NGNGO; Yerevan, Armenia), represented by president Sergey Gabrielyan
- Bavarian Youth Council (BJR; Bavaria, Germany), represented by president Matthias Fack

met from July 22-27, 2018 in Yerevan as part of delegation program to discuss their strategy for a future cooperation. Both sides confirm, that they enrich each other by sharing their experiences and competences to build up a strong and sustainable youth policy as well as structures that allow youngsters to take part in educational valuable youth exchanges with meaningful contents.

Therefore, the organizations declare their intent to sign a memorandum of understanding during the General Assembly of the BJR from October 19-21, 2018 in Gauting (Bavaria) with the following contents:

- a strategic partnership, especially to apply for further fundings to improve and extend their programs,
- focus on intercultural exchange to promote peace and understanding – creating the basis for open-minded, compassionate interaction,
- develop common projects, e. g. on human rights and democracy

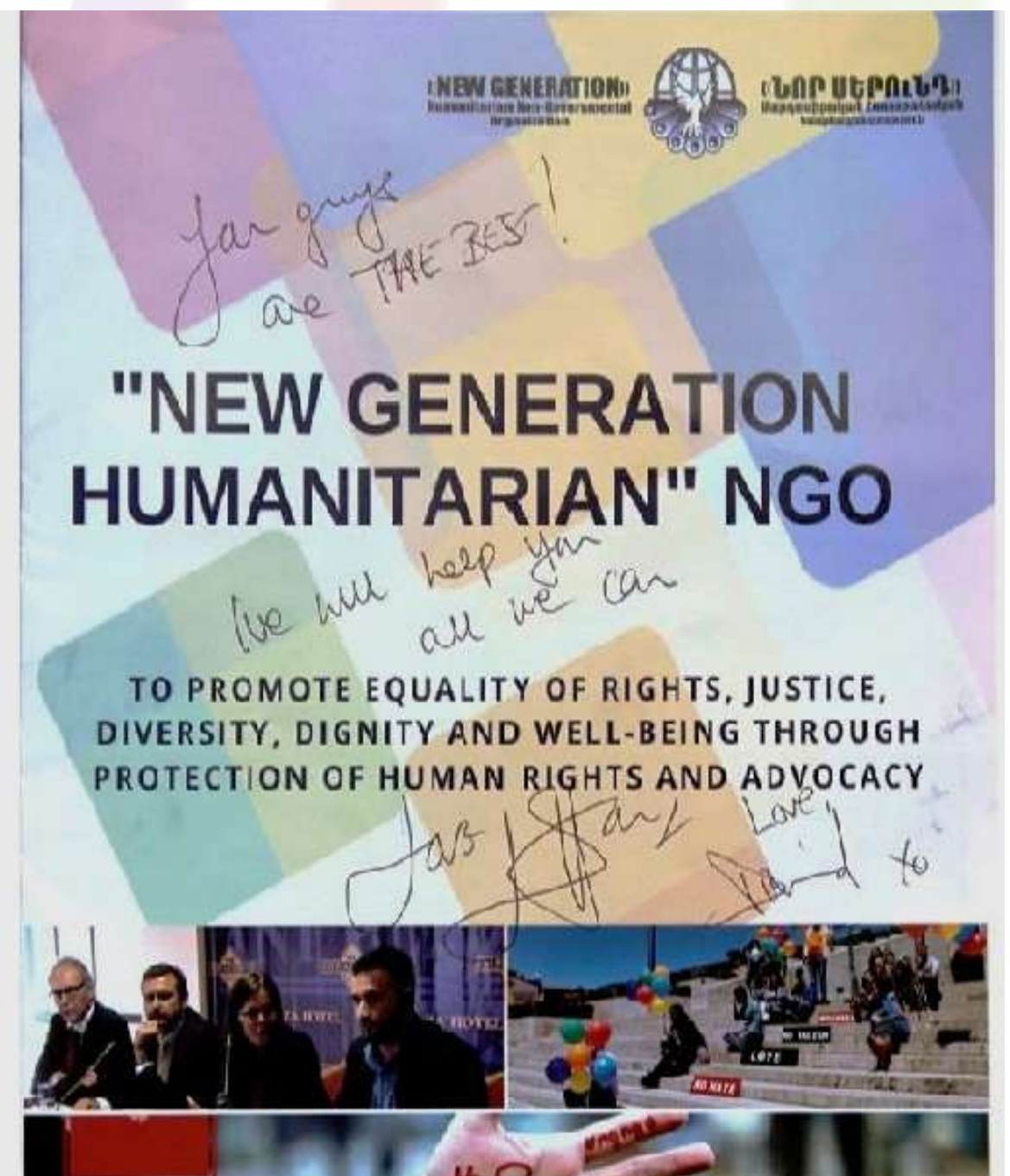
Therefore, BJR invites three representatives of NGNGO to its General Assembly in October.
